

NLA Database Licence Fee Tariff

These rates apply in respect of Database Services from 1 July 2010 unless and until amended pursuant to the terms of the PCA Licence General Terms and Conditions and/or the terms of the Database Licence.

All fees set out in this Database Fee Tariff exclude VAT, which (where applicable) is payable in addition.

In this Database Fee Tariff, capitalised terms have the meanings given to them in the Database Licence and/or the PCA Licence General Terms and Conditions (unless otherwise stated).

Database Access Service – Subscription Tariff

The Database Access Service fees are as follows.

- (1) **Annual Subscription Fee** (payable in advance in twelve equal monthly instalments, the first instalment being due on the Service Invoice Date and subsequent instalments being due on the first day of each following calendar month during the Term)

- (2) **Charge for Cuttings** (payable monthly in arrears from the Start Date) – 9.6 pence for each Cutting made available to a Client or a Prospective Client.

Database Access Service - Pay As You Go Tariff

The Database Access Service (PAYG) fees are as follows:

- (1) **Annual Subscription Fee** (payable in twelve equal monthly instalments, the first instalment being due on the Service Invoice Date and subsequent instalments being due on the first day of each following calendar month during the Term) - £11,360
- (2) **Charge for Links** (payable monthly in arrears from the Start Date) - £1.00 for each Link sent to a Permitted User or a user at a Prospective Client.

XML Data Feed Service

The XML Data Feed Service fees are as follows.

- (1) **Annual Subscription Fee** (payable in advance in twelve equal monthly instalments, the first instalment being due on the Service Invoice Date and thereafter on the first day of each calendar month during the Term)

- (2) **Charge for Cuttings** (payable monthly in arrears from the Start Date) – 9.6 pence for each Cutting made available to a Client or a Prospective Client.

Image Data Service

The Image Data Service fees are as follows.

- (1) **Annual Subscription Fee** (payable in advance in twelve equal monthly instalments, the first instalment being due on the Service Invoice Date and subsequent instalments being due on the first day of each following calendar month during the Term)

(2) Charge for Cuttings – 9.6 pence for each Cutting made available to a Client or a Prospective Client.

Database Core Repertoire - Scanning Fee Reduction

The scanning fees payable under a Paper Licence and/or an Electronic Licence for Text and/or Image scanning of Cuttings from the Database Core Repertoire will be reduced by 50% from the Service Invoice Date.

Audit Fee

A monthly fee is payable to cover audit costs as follows.

If in addition to a Database Licence, you also have a Paper Licence and/or an Electronic Licence, you will still only pay one audit fee as the audit fee covers audit costs incurred in respect of all PCA Licences which you have with us (whether a Paper Licence, an Electronic Licence and/or a Database Licence).

Default Charge

For each day's default in delivering to us a return in accordance with clause 10.2 of the Database Licence you will pay us as liquidated damages to compensate us for our additional administrative effort a fee of £25 per day. Where you are in default in delivering to us returns in accordance with clause 3.1 of the Paper Licence and/or clause 5.2 of the Electronic Licence (as the case may be) you will pay to us in addition the separate default charges due under that Paper Licence and/or Electronic Licence (as applicable).

Renewal Fee

Where your Database Licence has been terminated by the NLA pursuant to clause 3.2.3 of the PCA Licence General Terms and Conditions, you are entitled to apply for a new Database Licence only upon payment of a renewal fee as follows:
